- 3. Any student found short of attendance (minimum 80%) as per the Rules of Examinations of IPSM, New Delhi he/she shall not be allowed to appear in the Final Examinations. Such debarred students must repeat the course to be appear for the Final Examinations with required percentage of Attendance (80%).

- 4. If any student found indulge in unfair practice of means in the Final Examinations he/she be expelled and debarred from appearing in the examinations for one successive year.
